REVIEW OF THE YEAR

This year under review saw the National Library steering safely but slowly towards its defined vision, that is, to be:

- (a) the nation's leading documentary resource pertaining to the Republic of Mauritius and;
- (b) the apex institution serving the needs of the Mauritian people in research, scholarship and creativity.

Inspite of budget constraint, the National Library has increased its holding in library materials by making an acquisition of some 35,000 materials. This was mainly due to the generous donation of individuals and institutions and through its legal deposit regulations.

In line with one of its statutory obligations which is to act as the National Bibliographic Centre, it prepared the National Bibliography of Mauritius and maintained and updated the National Union Catalogue Database, a unified catalogue of Mauritian materials of twelve main libraries in Mauritius. An ambitious and bold endeavour had been the compilation of a Union List of Periodicals, accessible via the website of the National Library. It allows users to have a bibliographic detail of periodicals searched, including their location.

The National Library continues to develop itself as a vital national institution offering a quality service to Mauritians. The involvement of staff of the National Library needs to be acknowledged. Last, but not least, without the unflinching support of the Chairperson and Members of the National Library Board, not much would have been achieved. I would like to say a big thank you.

THE NATIONAL LIBRARY BOARD

The National Library is established under the National Library Act 1996 as a Body Corporate and is managed by a Board, consisting of a Chairperson and ten members.

The Chairman is a person of high academic distinction. Out of the eleven members, five are representatives of different ministries and departments, and the other six are appointed by the Minister of Arts and Culture, for a three-year period. As per statutes, board meetings are held at least once in a month, and nine members constitute a quorum.

PLANNING AND DEVELOPMENT

ISO 9001: 2000 PROJECT

With the ISO Certification awarded in January 2005, the National Library demonstrated its commitment to the delivery of quality services to its customers. Since then, the National Library is guided by the ISO 9001:2000 philosophy to continually improve its service offerings to meet customer requirements.

To comply with the ISO 9001:2000 standards, a corporate quality management system is in place. Regular internal audits have been conducted during the year under review to check compliance with the quality system. Minor non-conformities identified were immediately corrected. Management review committees were held thrice to review the situation and functioning of the system.

Throughout the year, Top Management held various meetings with staff to ease free-flowing forthright communication from Management to employees and from employees to Management. This mechanism further ensured that employees were motivated and that they developed the right attitude to work in a supportive work environment with the right policies, procedures, technologies, resources and structures.

CUSTOMER FOCUS

It is the policy of the National Library to provide its customers with a communication channel to systematically record their suggestions and complaints pertaining to various aspects of our services.

Customer Suggestions

Six suggestion forms were received during the period under review. They concerned the number of newspapers to be handed over to users at a time, the unavailability of recent newspaper indexes, and the introduction of a cash float system to facilitate cash transactions. Two forms expressed satisfaction with the services and the personnel of the National Library.

Customer Complaints

Three complaint forms were received from customers. They dealt with the procedure for registration and the unavailability of a specific document. Replies have already been sent to the individuals concerned.

User Satisfaction Survey

In line with the requirements of ISO 9001:2000, the National Library carried out its second annual user satisfaction survey in January 2007. Fifty questionnaires were distributed to users on the basis of a simple stratified random sampling technique targeting the four major user groups, namely: general public,

researchers, students and foreigners. The overall response rate was 80 %. The data collected were analysed and a report was submitted to management for necessary action.

In general, users were satisfied with the ease of access, lighting, seating and comfort level, the use of the Online Public Access Catalogue, the availability of the information requested, the responsiveness of the staff, the Internet service, photocopy service, newspaper corner, the communication policies of the National Library and the waiting time.

62 % of respondents made suggestions and comments on issues such as lighting, seating and comfort level, computer / Internet facilities, registration formalities, staffing level, opening hours, photocopy service, the collection, and the preservation of newspapers.





NATIONAL LIBRARY MANDATES

NATIONAL BIBLIOGRAPHY OF MAURITIUS

The National Library of Mauritius has the statutory obligation to act as the National Bibliographic Centre to prepare and maintain the National Bibliography of Mauritius. The National Bibliography includes works in different formats, that is, monographs, magazines, journals, pamphlets, newsletters, reports and newspapers printed, published and produced in Mauritius, works written by Mauritian authors and also works produced overseas by foreigners relating to Mauritius are acquired by the National Library.

The National Bibliography of Mauritius is an indispensable bibliographic tool at the service of researchers, university students and other information seekers. It provides complete bibliographic details such as, title, author, editors, subject and even class number to facilitate their identification. The National Bibliography of Mauritius for the years 2004 and 2005 is under way and is due to be published soon.

NATIONAL UNION CATALOGUE (NUC)

The NUC is a unified catalogue or a collection of Mauritiana materials held by twelve libraries of Mauritius. Libraries participating in this endeavour include the following:

- 2. The City Library;
- 3. The Olof Palme Library;
- 4. The Simone de Beauvoir Library;
- 5. The Carnegie Library;

The National Library's Website enables customers to have direct access to NUC. Moreover, researchers and other information seekers can easily browse the NUC to identify and locate items held by these cooperating libraries. It also facilitates resource sharing among libraries through inter-library loan.

For the period under review, **5,528** records have been added to the NUC database. The total number of bibliographic records currently available in the NUC amounts to **45,368**.

UNION LIST OF PERIODICALS (ULP)

The ULP is an ambitious collaborative endeavour involving fourteen major libraries of Mauritius. It consists in the compilation and production of an online list of periodicals subscribed by the participating libraries, which are:

- 1. The University of Mauritius;
- 2. The Ministry of Agro-Industry and Fisheries;
- 3. The University of Technology; Mauritius
- 4. The Mauritius College of the Air;
- 5. The Knowledge Centre of Enterprise Mauritius (ex-Trade Information Centre of MIDA).
- 6. The Mauritius Meteorological Service Library;
- 7. The Carnegie Library;
- 8. The Ministry of Finance and Economic Development Library;
- 9. The Chinese Cultural Centre in Mauritius;
- 10. The Grand Bay Public Library;
- 11. The Olof Palme Library;
- 12. The 'Institut Supérieur de Technologie';
- 13. The Documentation Unit of the Ministry of Arts and Culture;
- 14. The National Library.

The ULP service, which is accessible via the Website of the National Library, enables customers to view bibliographic details of periodicals, their location and holdings. The National Library is responsible for updating the list.

COMPUTERISATION

With recent developments in information and communication technologies, tremendous changes have taken place in libraries worldwide. Effective organisations are characterised by changes initiated in response to internal and external forces. Consequently, the National Library has, since 2004, embarked on and consolidated the computerisation project by improving online services through its Website.

WEBSITE

In today's knowledge-driven society, it is crucial for the National Library to be efficient and effective in meeting the demands of its customers both at national and international level. Consequently, the National Library is regularly creating and updating value-added services through its Website. An open archive for electronic / digital publication is now available online from the Website of the National Library. Past annual reports, strategic plans, the Directory of Libraries and the Documentation Centres, application forms for ISSN and CIP and the National Bibliography of Mauritius are now accessible to customers. Through its user-friendly and interactive interface, the Website has proved to be of immense aid to customers.

ONLINE PUBLIC ACCESS CATALOGUE (OPAC)

All bibliographical data related to acquired material are inputted on a daily basis into the database of the National Library and these are accessible through its Website. The OPAC, which is an online catalogue of library materials, ensures global access to the rich collection of the National Library of Mauritius. As at 30th of June, a total of 32,914 documents have been entered in the OPAC system. New entries for the year 2006-2007 amount to 3,582.

INTERNATIONAL STANDARD SERIAL NUMBER (ISSN)

The ISSN is managed by a worldwide network of seventy-seven National Centres, coordinated by an International Centre from Paris and backed by UNESCO and the French government. It uses a standardized international code which enables the identification of any serial publication, including electronic serials, independent of its country of publication, language, frequency and medium. It is a unique eight-digit number allocated to serials (Newspapers, Magazines, Annual Reports, Year Books, Directories, Newsletters, Transactions of Societies and E-journals). The National Library acts as the National ISSN Centre for Mauritius and Rodrigues. For the year under review, the National Library has processed 10 ISSN applications.

CATALOGUING-IN-PUBLICATION DATA (CIP)

Since 2001, the National Library has been offering the CIP service free to local authors, printers and publishers. A CIP data is a bibliographic record prepared by the National Library, using the Anglo-American Cataloguing Rule II, the Dewey Decimal Classification Scheme (22nd edition) and the Library of Congress List of Subject Headings, for books not yet published. When the book is published, these data are included on the verso of the title page to facilitate book processing for libraries. During the period under review, the National Library has produced 22 CIPs.

CONSULTANCY IN LIBRARY AND INFORMATION SERVICES

The National Library provides its expertise in Library and Information Services to Ministries/ Departments and other public institutions in the setting up or re-organisation of their libraries or documentation centres. Consultancy services have been given, free of charge, to several organisations at national level as follows:

ACQUISITION AND PROCESSING OF LIBRARY MATERIALS

HOLDINGS OF THE NATIONAL LIBRARY

One of the main objectives of the National Library is to acquire Mauritiana materials comprehensively through legal deposit whereby printers and producers are required to deposit six copies of each library material free of charge. Another source of acquisition is through donation. During the year under review, donations were received from the United States Embassy, the Mauritius Telecom, the International Labour Organisation, the Pakistan High Commission, the Rodrigues Regional Assembly, Organisation Internationale de la Francophonie, and the Mauritius Tourism Promotion Authority. Moreover, an important donation was received from an anonymous person.


The holdings of the National Library as at 30th June 2007 were 314,327.

CLASSIFICATION AND CATALOGUING

Classification and cataloguing are technical services, whereby technicians process library materials to facilitate their accessibility. Classification is a system of coding and organising documents according to their subjects and allocating a call number to each and every information resource.

A library catalogue serves as the key to exploit the collection. By providing bibliographical data, the catalogue assists customers in the identification, location and easy retrieval of library materials.

During the year under review, **1,946** titles were catalogued and classified at the National Library. Cataloguing was based on Anglo-American Cataloguing Rules (2nd edition), whereas classification was done according to the Dewey Decimal Classification Scheme (22nd edition). Subject headings were derived from the Library of Congress Subject Headings (22nd edition).

INDEXING AND ABSTRACTING

An index is a tool to facilitate the retrieval of specific documents. Abstracting is an integral part of the indexing system that enhances the accessibility of the original document. The primary objective of indexing and abstracting is to capture the essential content of a document. The Library of Congress Subject Headings was used as guide to prepare indexes for the following newspapers and periodicals:

- L'Express 1994-1996
- Le Mauricien 1994-1996
- Business Magazine 2006-2007
- Islander 2006-2007

The total number of articles indexed and abstracted was 3,051.

PRESERVATION AND CONSERVATION

Preservation is the theory and practice of actively maintaining library collections for posterity. The National Library is committed to the care and preservation of its collection. Paper-based format is the most strongly represented format of the library collection. Preservation includes conservation which is the reactive

treatment of library materials to strengthen them physically or stabilize them chemically, thus sustaining their survival as long as they are needed in their original format.

The storage environment of the collection has a dramatic effect on the long-term usefulness of the collection and the information it contains. Key factors to consider are: temperature, relative humidity, light, pollutants and pest. The Library maintains the collection by providing appropriate storage conditions on an ongoing basis and takes action to treat, replace and reformat it, using protective measures. The Library looked for preventive measures to minimize damage resulting from environment by controlling temperature and relative humidity on a daily basis. It also controlled light and kept the environment clean to enhance the longevity of its collection.

BINDING SECTION

Binding is a preservation-related activity. The Binding section is responsible for the care of the library's collection by providing these facilities:

- -Minor repairs of slightly damaged materials to extend their use.
- -Binding to compile the maximum number of issues in a bound volume.
- -Strengthen paperbacks to increase their circulation life.
- -Binding unbound monographs and serials
- -Providing boxes for fragile, brittle or severely damaged materials.

MICROFILMING

Library materials deteriorate with age and use. The increasing demand for access to rare and fragile materials has made reformatting a widely adopted preservative measure. Preservation includes reformatting and the recording of information in one medium to another. The most common reformatting method is microfilming, whereby printed information on paper material is converted to film.

Newspapers are a primary source of local history and information. They are worthy of retention and preservation as they are vulnerable to decay.

PHOTOGRAPHS

Photographic images play a primary role in the documentation of historical events. They freeze in time those moments. Photographic preservation is more complex than most documents or paintings. Original prints are extremely sensitive and can easily be damaged by improper storage, careless handling and exposure to the environment. The National Library acquired photographs as donation, which are mostly in black and white. During the year under review 57 photographs were cleaned, accessioned and filed.

TRAINING OFFERED BY THE NATIONAL LIBRARY

- *Ms Rahimbaccus Kenza*, staff from Tropic Knits Ltd, attended an on-the-job training in *'library and information work'* from 23rd January to 13th February 2007.
- Mrs Caussy Preethee, Library Clerk at the Black River District Council library, attended an in-serving training programme in 'library and information work' twice a week for the period 03rd April to 31st May 2007.
- Mr Guillaume Josique, Senior Library Clerk at the Commission for library services of the Rodrigues Regional Assembly, and actually following the Diploma Course in Library and Information Studies at the University of Mauritius, is on training at the National Library since 14th August 2006, for a period of two years on the days he will not be following courses at the University of Mauritius.






SERVING OUR CUSTOMERS

The National Library strives to provide customer-oriented library and information services. Understanding and satisfying their information needs has been our constant preoccupation. In this respect, a range of services is being offered in a spacious and air-conditioned search room.

The number of users who have benefitted from the reference information service has been continuously rising. For the period under review, the National Library has welcomed **7,897** customers, representing an increase of 8.6 % over the previous year. It is noteworthy that since its opening in January 2000, the National Library has been providing information services to **44,533** users.

The growth in the number of customers is illustrated hereunder.







OUTREACH ACTIVITIES

WORLD BOOK DAY CELEBRATIONS 2007

The World Book and Copyright Day is celebrated since 23rd April 1995 on a worldwide basis and the National Library, along with its stakeholders, has taken the initiative since 2003 to celebrate it on a national basis in Mauritius. One of the main objectives of this celebration is to make good books available to the general public at discounted prices, contributing to the attempt to inspire children, and adults as well, to read. As Koïchiro Matsuura, the Director-General of UNESCO said, books are a unique tool for expression, education and communication. Indeed, the National Library is not about lifeless books sleeping on shelves, it is an institution that is actively growing and one of its objectives is to encourage reading habits, hence it's organising of the World Book Day.

The theme for this year's celebration was the same as last year, given its laudable impact: "Lire, Grandir & Réussir". By involving the stakeholders of the book established in Mauritius, like the Centre de Lecture et d'Animation Culturelle (CLAC), the Mahatma Gandhi Institute, the Mauritius College of the Air, the National Computer Board, Embassies, Cultural Centres, booksellers and distributors to speak of only a few, the National Library has provided a national platform which attempts to give books their rightful place in today's fast-paced world. The help and support of, among others, the Ministry of Arts and Culture, Ministry of Public Infrastructure, Land Transport & Shipping, Ministry of Public Utilities, along with the District and Municipal Councils were sought for this occasion to help promote the World Book Day. The local press and advertising agencies also joined in this common enterprise to make the event a success.

With a view to reach the majority of the Mauritian population, the World Book Day was celebrated in three different regions of the country, namely at the Port Louis Waterfront on the 28th April, at the Mahebourg Waterfront on the 12th May, and in Goodlands on the 2nd June 2007. If people are hesitant to reach out for books, the National Library is well inclined to bring the books to the population. The Prime Minister, Honourable Dr. Navinchandra Ramgoolam was the Chief Guest at the Opening Ceremony of the World Book Day Celebrations at the Port Louis Waterfront and in his address he declared that books were a means of enriching and enlivening the nation's thinking.

At the celebrations held at Mahebourg, Mr. Raouf Bundhun, the Vice-President of the Republic of Mauritius, was the Chief Guest and Hon. Mahendra Gowressoo, Minister of Arts and Culture also graced the ceremony by his presence. This year, for the first time, the National Library celebrated the World Book Day in Goodlands, where several eminent personalities, among others, Hon. Dharam Gokhool, Minister of Education & Human Resources and Hon. Madan Dulloo, Minister of Foreign Affairs, International Trade & Cooperation were present. A symbolic donation of books to some primary schools of the region was also held on that day, thus contributing to the mission of making Mauritius a reading nation.

Several activities, among others, quizzes, drawing competitions, reading contests, poem recitals, spelling contests and exhibitions were held during the three Book Festivals, which generated a high rate of interest and participation of children, youngsters and adults. There was also a distribution of school kits, balloons, books, sweets and biscuits, but even better was the availability of a large variety of books at promotional prices, provided by different bookshops. Moreover, two cybercaravans operated by the National Computer Board were also present during the whole day to promote ICT literacy. There were live musical programmes



INTERNATIONAL CONFERENCES & SEMINARS PERIOD JULY 2006 TO JUNE 2007

Participation of the Director to a Professional Stay in France from 13 to 20 November 2006

In the context of the Cultural Exchange Programme between the Republic of France and the Republic of Mauritius the Director of the National Library was invited in France for a professional stay from 13 to 20 November 2006.

Mr Fred Constant, the *Conseiller de Coopération et d'Action Culturelle* at the French Embassy prepared an excellent schedule of working sessions, in connection with the specific needs of the National Library of Mauritius. Emphasis was set on three essential areas, respectively:

- Bibliographical search of all publications related to Mauritius and their possible dispatch to Mauritius, either by microfilming, photocopy or in numeric forms;
- · Digitalisation techniques; and
- Short training courses for library staff at the Bibliothèque Nationale de France.

During his stay in France, the Director of the National Library, visited firstly the Bibliothèque Nationale de France from 14 to 15 November 2006. He was warmly welcomed by Mrs Marie-Claire Germanaud, *'Responsable de la Délégation aux Relations Internationales'*. The Director had the privilege to have a meeting with Mr Jean-Noël Jeanneney, Chairman of the Bibliothèque Nationale de France, who promised to help the National Library in its future development. He also had work sessions with other senior executives. Mr Denis Bruckmann, *'Adjoint au Directeur des Collections pour les Questions Scientifiques et Techniques'* gave him a guided tour of the François Mitterand Complex, established since 1368, by Charles V when he set up his own library of about 917 manuscripts at the Louvres (*Tour de la Fauconnerie*).

On 16 November 2006, the Director, went to the Archives Nationale de France and discussed with Mrs Elizabeth Rabut, *Chef de l'Inspection Générale*, about future cooperation between the two institutions.

The Director then headed for the Centre des Archives d'Outre-Mer at Aix-en-Provence on 17 November 2006, where he had the opportunity to see *de visu* all cards and plans of fortifications and churches. He also made an inventory of the rich collection of printed documents and periodicals related to Mauritius for a further comparative study.
