All results were obtained using groups of mice that were run in several cohorts. Fiber photometry results were replicated using two different calcium indicators (gCaMP6f and gCaMP6s).

Animals with incorrect electrode/optical fiber placements were excluded from analysis.

Animals that showed low conditioned fear (< 50% freezing) at the start of the extinction session were excluded from the study. This criterion led to the exclusion of 1 mouse from photometry and 1 mouse from optogenetics experiments.
