Preface

The modest roots of the present bibliography lie in a private bibliography of the author and an MLA inquiry made in September, 1993, as part of preparations for a seminar on Focus in Winter, 1993/4 at the Department of Linguistics at the University of Cologne. The combination of the two bibliographies yielded approximately 400 titles and was unsystematically supplemented, in the course of the time, by items quoted in the reference lists of the various publications dealt with in the seminar. A considerable number of further entries was suggested by colleagues and students during 1994. A particularly large number of additions came from a bibliography on focus typology compiled by Bernhard Drubig in Tübingen and kindly made available to me in Fall, 1994. Finally, a second MLA inquiry was started a couple of weeks ago in order to get hold of the most current publications. All of this has led to a considerable increase in the amount of the material, with the result that, in its present form, the bibliography contains approximately 1100 entries.

Bibliographical work is never complete, and the present one is still modest in a number of respects. It is not annotated, and it still contains a lot of mistakes and inconsistencies. It has nevertheless reached a stage which justifies considering the possibility of making it available to the public. The first step towards this is its pre-publication in the form of this working paper. Comments, additions and corrections are highly welcome. I assume that the last few years are more or less completely covered as far as the major and "official" sources are concerned, but there are certainly a number of smaller working papers and similar semi-publications which have escaped my attention. The bibliography is less complete for earlier years. For works before 1970, the bibliographies of Firbas and Golková 1975 and Tyl 1970 may be consulted, which have not been included here. For further suggestions, in particular, concerning works between 1970 and the early eighties, I would be extremely grateful.

An additional warning is in order with respect to the correctness and completeness of the entries. For reasons of time, I was unable to verify diacritics and other spelling devices in every case. This is particularly problematic for entries obtained from the MLA search since the MLA format never contains any diacritics, so that the correct spelling of names and titles has to be checked elsewhere. Furthermore, older sources are often quite loose in their bibliographical references and do not always give page numbers, publishers and other important information. We have tried to fill in these gaps to the best of our knowledge by comparing the references in major bibliographical works such as the Linguistic Bibliography, but a number of questions still remain.

The present bibliography is also available on disk (Macintosh Word 5.0) and can be obtained from the author (address: Hans-Jürgen Sasse, Institut für Sprachwissenschaft, Universität zu Köln, D-50923 Köln, Germany).

My deepest thanks go to all those who have contributed, in one way or another, to the present form of the work, in particular: all members of the 1993/4 Focus seminar; Barbara Wehr (Mainz) and Bernhard Drubig (Tübingen), who corrected mistakes in an earlier draft and contributed a considerable number of entries; Silvia Kutscher, Barbara Otto and Carmen Rudolf for invaluable help with the MLA search and the preparation of the final draft of the typescript.
